 any pictures, video or text that could upset, offend or threaten the safety of any
 member of the school community or bring the school into disrepute. This includes
 the use of the Class Dojo system.
- Support the school in any guidance about uniform, jewellery and also about items which should not be brought to school, ie. mobile 'phones and toys

<u>Uniform</u> – I/we agree with the uniform and dress code set out below:

- Plain black or grey school trousers/shorts/skirts
- White/jade school polo shirt
- Shoes black, polishable, low-heeled/flat-soled, no trainers, slip-ons or Crocs
- Socks to be worn with all footwear
- Summer dresses to be blue gingham style
- Earrings studs only and child must be able to remove and put in independently
- Long hair to be suitably tied back only small navy blue hair accessories no Jojo bows or novelty hairbands are to be worn
- No make up or false nails to be worn nail polish to be of a subtle shade if worn
- PE Kit plain navy shorts, light-blue school PE t-shirt, trainers, school jumper, plain dark tracksuit bottoms. No football shirts or designer clothing

- The internet will be used only with permission from a member of staff
- All internet activity should be appropriate to pupils' activity
- Access should be made only via the authorised logins and passwords

- Copyright materials must be respected
- Posting anonymous messages and forwarding chain letters is not allowed
- Offensive and insulting language is not to be used on ICT systems
- Use of the network to access pornographic, racist, offensive or any other inappropriate material is not allowed
- Pupils will not access other people's files
- Pupils should report any unpleasant material or messages received
- Pupils must not access social networking sites, or attempt to access blocked websites by any means
- Students must not download or install software onto school ICT systems
- The school may check computer files and monitor the internet used by students
- Adults and pupils will support the school's approach to E-Safety and not upload or post to the internet any pictures, video or text that could upset, offend or threaten the safety of any member of the school community or bring the school into disrepute.
